Applications are subject to approval by the Yadkin Valley Wine Festival Committee and space limitations. Applications received before **03/31/2018** will receive priority consideration for location and special requests. Applications received after that date are not guaranteed such consideration, depending on space and planning limitations, and will incur a non-refundable \$50 late fee.

**A certificate of general liability of at least \$1 million naming the Yadkin Valley Chamber of Commerce and the Town of Elkin as additional insured for May 18-20, 2018 must be provided to the Chamber upon acceptance of this application.**

**NOTE:**

- Wineries/vineyards with a physical presence outside the Yadkin Valley or Swan Creek AVAs may only pour or sell wines that have a TTB label indicating 'Yadkin Valley' or 'Swan Creek' appellations.
- Paid attendees will have their photo ID checked and a tasting wristband affixed at check-in. Wineries may NOT pour samples or sell any wine to any individual without a tasting wristband. Friday set-up from 12noon to 4pm by appointment. Saturday setup from 7am to 10am. Winery must remain on site until 5pm Saturday.
- Wineries/vineyards may not sell "wine slushies."
- Wineries/vineyards may only sell or pour from containers with TTB approved 'Sangria' labels.

**I/we understand this application becomes a binding contract when accepted and signed by Yadkin Valley Chamber of Commerce. I/we agree to abide by any rules and regulations published here as well as any additions. Wineries will receive 2 festival glasses, 2 VIP/hospitality tent wristbands, 6 extra staff tasting wristbands, and up to 6 food vouchers redeemable at food vendors during the festival. Wineries will need to provide their own glasses for the extra staff tasting wristbands.**
